Do your telephones meet North
American safety standards?

SAFETY STANDARDS

- ✘ For U.S and Canadian market entry, all terminal equipment must meet national product electrical safety requirements.
- ✘ **Warning:** Not all telephones sold for installation in hotel guestrooms meet these standards.
- ✘ If the telephones you have purchased do not meet electrical standard, your property could be at risk for electrical fires and guest insurance claims.



SAFETY CERTIFICATION

- ✘ Intertek is a global leader in the testing, inspection, and certification of electrical products.
- ✘ Intertek tests to applicable ANSI, UL, and CSA standards.
- ✘ In the U.S., Intertek is an OSHA-recognized national testing laboratory (NRTL).
- ✘ In Canada, Intertek is recognized as a Testing Organization (TO) and a Certification Body (CB).



ETL MARK

- ✘ A product bearing the ETL Listed Mark (CUS) has been tested by Intertek and meets the minimum requirements of U.S. or Canadian electrical safety standards.
- ✘ A product bearing an ETL Listed Mark reflects a manufacturer's dedication to the safety and quality of their products.



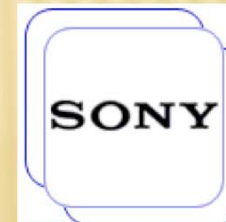
