

Statement of Limited Warranty

Cetis, Inc. (Cetis) warrants to its customers that Cetis products are free from defects in materials and workmanship. For customers in the United States and Canada product warranties are as follows:

Under all circumstances, handset batteries, either NiCd or NiMH, used in cordless products and AC adaptors are covered by a one (1) year warranty. If a product fails this warranty during the warranty period and end user is located in a service region, Cetis will, at its option, either repair or replace the defective product or parts, or deliver replacements for defective products or parts on an exchange basis at no additional charge to the customer except as set forth below. Repair parts or replacement products may be either new or reconditioned. Products or parts returned to Cetis under this warranty will become the property of Cetis. Warranties on products repaired by Cetis expire at the termination of the original warranty period.

International Service Regions

Customers located in Australia, Europe and the UAE & Oman are defined as “in service region” and will receive the following:

- 2% morePhone program, and
- Relevant product warranty as outlined above

Europe will be defined as Albania, Andorra, Austria, Belgium, Bosnia & Herzegovina, Bulgaria, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxemburg, Macedonia, Montenegro, Netherlands, Norway, Poland, Portugal, Romania, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, and United Kingdom.

This limited warranty does not cover:

1. Products or parts, which are damaged, abused or misused;

5. Damage in transit to the Cetis repair facility;
6. Any product or part unless proof of date of purchase is submitted with the product when returned for warranty repair; or
7. Costs incurred by the customer in removing and shipping the product to Cetis for repair or replacement, and costs of reinstallation of the product.
